aggregate not more than ten percentage of the total share capital of the company carrying voting rights. Members holding more than ten percent of the total share capital of the company carrying voting rights may appoint a single person as proxy, who shall not act as a proxy for any other member. If a proxy is appointed for more than fifty members, the proxy shall choose any fifty members and confirm the same to the company not later than 48 hours before the commencement of the meeting. In case, the Proxy fails to do so, the first fifty proxies received by the Company shall be considered as valid. The instrument of Proxy, in order to be effective, should be deposited, either in person or through post, at the Registered Office of the Company, duly completed and signed, not later than 48 hours before the commencement of the meeting. A Proxy Form is annexed to this notice. Proxies submitted on behalf of limited companies, societies, etc., must be supported by an appropriate resolution / authority, as applicable.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

Item No. 2

Ratification of remuneration of Cost Auditor

Pursuant to the provisions of Section 148 of Companies Act, 2013 and Companies (Cost Records and Audit) Rules 2014, Companies running Hospitals are covered under Table B (Non-regulated Sectors) of Companies (Cost Records and Audit) Rules, 2014.

The companies covered under Table B (i.e., Non-regulated Sectors) of Companies (Cost Records and Audit) Rules, 2014 are required to get their cost records audited if:

- the overall annual turnover of the company from all its products and services during the immediately preceding financial year is rupees one hundred crore or more, and
- the aggregate turnover of the individual product or products or service or services for which cost records are required to be maintained under rule 3 of Companies (Cost Records and Audit) Rules, 2014 is rupees thirty five crore or more.

As per accounting records of the Company, the threshold was exceeded in preceding financial year (i.e., 2023-24).

The Board of Directors had approved the appointment and remuneration of M/s. Pawan & Associates, Cost Accountants (FRN- 101729), to conduct the audit of the cost records of the Company for the financial year ending 31st March, 2025.

In terms of the provisions of Section 148(3) of the Companies Act, 2013 read with Rule 14 of the Companies (Audit and Auditors) Rules, 2014, the remuneration payable to the Cost Auditors is required to be ratified by the Members of the Company.

Accordingly, consent of the Members is sought to ratify the remuneration payable to the Cost Auditors.

Accordingly, the Board of Directors recommend the Resolution set out as Item No. 2 of the Notice for approval of the Members of the Company.

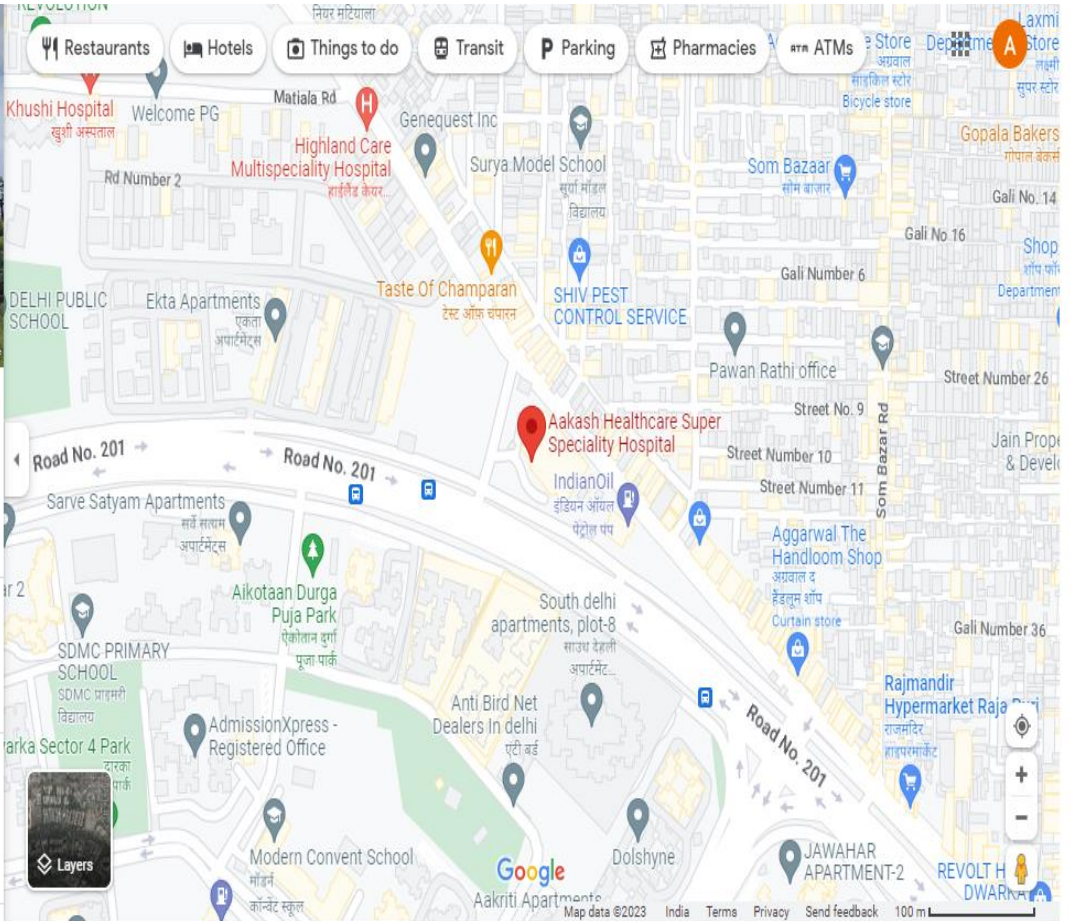
